counsel nationwide on a variety of litigation matters has highlighted the importance of being proactive in responding to the significant civil and criminal costs and risks of e-discovery, e-compliance, data privacy, and records management.

Laura is a widely sought-after speaker, writer, and television commentator on a variety of litigation, corporate records management, and e-discovery issues, including the failures that contributed to the Arthur Andersen-Enron collapse. She has lectured on protecting corporate officers from civil and criminal sanctions, including obstruction of justice, in the context of litigation and SOX records preservation requirements. She also has spoken on good records creation practices; records information management, legal holds, and e-discovery; addressing documents and document-related issues in high-stakes cases; defending and affirmatively using company documents at trial; the applicability of the attorney-client privilege to corporate communications; litigation communication; and minimizing punitive damages.

Laura was the lead author of a Baylor Law Review article analyzing punitive damages trends and suggesting strategies for defending against punitive damages claims. She co-authored an article on litigation and non-litigation strategies to limit corporate liability for punitive damages, which was published in the Federation of Defense and Corporate Counsel Quarterly. She also has co-authored a paper addressing the risks of waiving privilege when disclosing confidential information to the government and external auditors. Most recently, Laura and her partner, Jim Daley, have authored the United States section of a book chapter in Electronic Evidence, published by Lexis Nexis; and have written "International Restrictions on Releasing Personal Information: What Steps Your Company Needs to Consider," which was published in The Corporate Counselor®.
